## **GENERAL TERMS AND CONDITIONS OF BUSINESS**

**FOR THE iba. OKTOBERFESTZELT 2018**

### **Provisional reservation**

Your reservation shall remain provisional until it has been confirmed (activated) by our reservations office Able Catering GbR. The customer shall not have any entitlement with regard to such a provisional reservation. If the customer does not send a return confirmation in time, the provisional reservation shall expire automatically.

### **Conditions of reservation**

A reservation can only be made in connection with payment of the reservation fee. The reservation includes a cold platter placed on the table, a choice of main course, a dessert and one litre of beer/soft drink per person. The cost is EUR 49.00 per person. Each person will be issued with a voucher for the above food, drinks and service.

### **Binding nature of the reservation and voucher**

The invoice shall be payable within 14 days of the invoice issue date. If payment is not made on time, the provisional reservation shall expire. Please state the corresponding invoice number when making payment transfers. Bank charges arising for international transfers shall be borne by the customer. The meal vouchers can be collected directly from the iba.OKTOBERFEST TENT from 15 to 19 September 2018. Daily from 4.00 p.m.

### **Commitment to the reservation**

All reserved places must be occupied promptly. Reserved places can be kept free for a maximum of 25 minutes after the ordered time. Places which are not occupied in time shall be allocated elsewhere by us. If all occupants leave a table, they shall relinquish the right to the seats.

### **Withdrawal by the Customer**

The Customer may withdraw from a reservation in full or in a multiple or multiples of 8 persons by 1 September 2018 by submitting a written declaration, subject to an administration fee of EUR 150.00 per table (8 persons). In the event of a withdrawal or a reduction in the number of persons 9 to 6 days before the event, 50% of the fee shall be charged; if this occurs from 5 to 1 days before the event or on the day of the event itself, 100% of the fee shall be charged.

### **Right to make modifications**

The company Able Catering GbR shall be entitled to modify the service owed or to deviate from it in a way which is reasonable for the Customer, having regard to the Customer's interests.

### **Payment**

Payments shall be made without any deduction immediately before leaving the tent by means of the meal/drinks voucher and/or in cash and/or by credit card (EC, Mastercard, Visa). All prices stated in the terms and conditions of business are gross prices, inclusive of statutory VAT. If the amount of food and drink consumed is higher than the value of the voucher, the additional amount may be settled in cash or by credit card. If a guest wishes to receive an invoice for the additional amount of food and drink, this must be notified to the service personnel or to the management on the reservation date.

### **Withdrawal by Able Catering GbR**

If, on the reservation date, it is not possible to operate a festival tent – either in whole or in part – due to governmental orders, on security/safety grounds, due to force majeure or for other important reasons, the vouchers purchased at the time of the reservation shall be reimbursed on their return. No more extensive rights shall exist vis-à-vis Able Catering GbR in such cases.

**These general terms and conditions of business shall take precedence over other terms and conditions.**

**Where compatible, the place of jurisdiction shall be Munich.**
